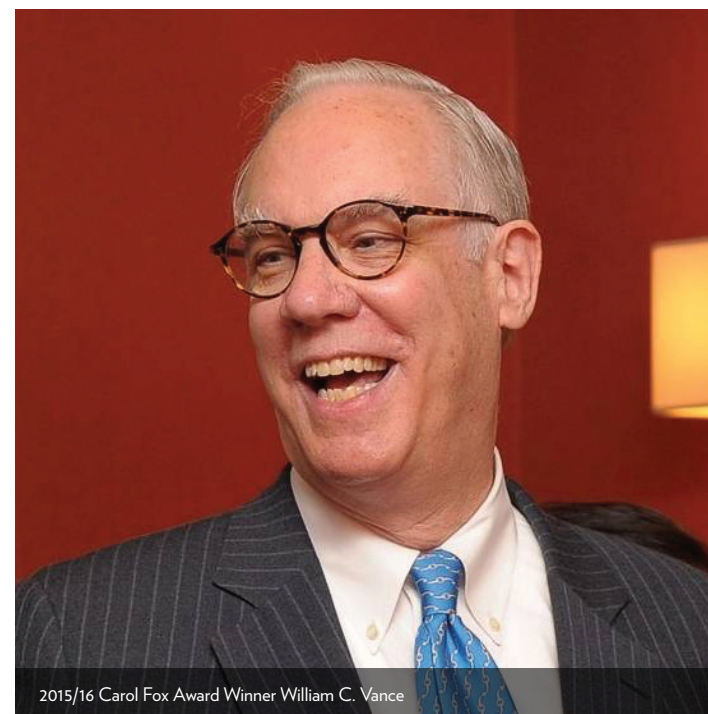

The 2015/16 season saw Lyric's *Breaking New Ground* campaign moving into its "public phase," focusing on much-needed stage improvements. As Lyric begins to prepare for the upcoming new *Ring* cycle, the long-awaited Lyric premiere of Berlioz's epic *Les Troyens*, and a new production of Mozart's *The Magic Flute*, three new stage lifts, 64 point hoist motors, and a new turntable (which can accommodate 19 tons of scenery) must be financed and installed.

When *Breaking New Ground* launched in 2012, the Lyric Board of Directors set out to modernize its stage equipment; update its media, marketing, and audience development programs; produce new and revived major productions of the highest caliber; and strengthen its balance sheet.

We were immensely gratified in December 2015 when *Breaking New Ground* surpassed the \$100 million threshold, something of a turning point for us. The entire Board of Directors and many of our longtime subscribers and patrons had been very generous during this "silent" phase of the campaign. We could now focus much of our efforts during 2015/16 on creating the stage improvements that have been necessary for Lyric's continual growth.

I'm very pleased with the company's dedicated adherence to our strategic plan, adopted in 2012. The plan's central themes remain: fiscal responsibility, artistic excellence, and relevance. As we look back at the 2015/16 season, certainly there were many extraordinary examples of artistic excellence, beginning with the new productions of *The Marriage of Figaro* and *Wozzeck* that opened the season. From those operas right through to the wonderful production of *The King and I*, it was, in fact, a remarkable year, accorded with consistent critical acclaim and audience enthusiasm.

The commitment to relevance had one of its major manifestations in Lyric Unlimited. This was a splendid year for community engagement, which included a great deal of planning and the execution of the opening phases of our new initiative, *Chicago Voices*. All of us at Lyric are looking forward to experiencing this two-year celebration of the human voice and its place in Chicago's cultural life curated by Creative Consultant Renée Fleming.

Fiscal responsibility remains paramount in the day-to-day functioning of the company. While ticket sales were something of a challenge this season, we maintain strong discipline in living within our means. We are, of course, enormously buoyed by the generosity of our donors and subscribers to the *Breaking New Ground* and the Annual Campaigns, reflecting the gratifying, ongoing support from our audience for this inspirational art form.

Starting in the summer of 2015, Lyric engaged in a very thorough and comprehensive operational assessment process. This was a concerted effort to conduct a financial and operational evaluation of how we do business, something that had not been attempted in our 61-year history. We are grateful to PwC, Strategy&, and Board members John W. Oleniczak, Paul F. Anderson, and Vinay Couto for the firm's pro bono service.

As a result of that initiative the company was reorganized around five lines of business: Opera, Musicals, Ryan Opera Center, Lyric Unlimited, and Presentations and Events. This aligns with what we now call "centers of expertise": development, human resources, marketing, information technology, and finance. For example: we previously had a facilities department that oversaw the management of our most significant physical asset, the theater itself. That department has been transformed into "Presentations and Events," with our former Director of Facilities Rich Regan as General Manager. He and his colleagues are tasked with leveraging the Theatre's 80 to 90 "dark nights" for other events and concerts, which present an entirely new source of revenue for Lyric.

Lyric has also moved to budgeting and planning on a rolling three-year basis. Given that in opera, the company needs to make production and artist commitments many years in advance, this gives the institution a much better view into both costs and revenue needs ahead of time.

At last year's Annual Meeting, I spoke about "one Lyric" — the concept of bringing together the various disparate parts of Lyric into one idea and one theme. One suggestion I made was getting the voluntary boards working together and sharing member-at-large board members. Consequently, I was delighted on May 7 to witness the first-ever co-sponsored gala by the Women's Board and Guild Board. This was a marvelous example of the collaboration that I hope to see with increasing frequency from the boards and departments within the "tapestry" that is Lyric.

The first year of my tenure as President and CEO has been a great pleasure. Every aspect of this experience has both confirmed my enthusiasm for the company and everything it has to offer Chicago and, indeed, the world, as one of today's standard-setting cultural organizations. My thanks go to all the Lyric volunteer boards, to Anthony Freud, Sir Andrew Davis, Renée Fleming, and his Senior Management Team, and to the entire Lyric family for making the 2015/16 season such a success.

All of us at Lyric felt a tremendous cumulative excitement throughout the 2015/16 season, as one major event followed another. The mix of opera performances, concerts, and recitals provided a level of artistic achievement in which we can take justifiable pride.

Two Lyric Unlimited events provided a marvelous prelude to the season: in August, the world premiere of *Second Nature*, written and conducted by the exceptionally gifted Matthew Aucoin, presented for hugely enthusiastic family audiences at the Lincoln Park Zoo; and in September, our annual *Stars of Lyric Opera at Millennium Park* concert, which gave a capacity audience of more than 11,000 a thrilling preview of the season's first two productions.

Chicago Shakespeare Theater artistic director Barbara Gaines returned to open this season with her second Lyric production. Collaborating with debuting conductor Henrik Nánási and a gifted design team, Barbara approached Mozart's *The Marriage of Figaro* with a delightful comedic touch while also bringing out all the humanity of this miraculous work. Anchoring the cast were endearing portrayals from two of Europe's most delightful young artists, Adam Plachetka (title role) and Christiane Karg (Susanna). They were surrounded by a sparkling ensemble, including Luca Pisaroni, the debuting Rachel Frenkel, and—fresh from her triumph at the Met in this opera—Ryan Opera Center alumna Amanda Majeski.

Rossini's *Cinderella* returned to Lyric in a production I commissioned during my tenure at Houston Grand Opera. The astounding imagination of director Joan Font and his designers resulted in a fanciful, pricelessly funny, and absolutely fresh look at this gem of the buffo repertoire. The ravishing Isabel Leonard in the title role, Lawrence Brownlee in a sensational Lyric debut, and comic masters Alessandro Corbelli and Vito Priante all gave Lyric audiences enormous pleasure, as did our remarkable music director, Sir Andrew Davis, leading his very first performances of *Cinderella*.

Another milestone for Sir Andrew was his first *Wozzeck*, after many years of conducting Berg's other major works to great acclaim internationally. I cannot recall a more moving presentation

of *Wozzeck* than what we experienced in Lyric's new production of this groundbreaking work. Audiences and critics alike were riveted by the artistry of Sir Andrew; the insightful vision of director Sir David McVicar and his brilliant designers Vicki Mortimer and Paule Constable; and a stupendous cast, headed by Tomasz Konieczny and Angela Denoke in their Lyric debuts. All of us at Lyric were thrilled that this production was nominated for a prestigious International Opera Award.

The Metropolitan Opera's production of Lehár's *The Merry Widow* arrived in high style at Lyric, just in time for the holiday season. Our matchlessly alluring leading lady, Renée Fleming, sparkled again in her reprise of the title role, as did Ryan Opera Center alumna Nicole Cabell in the last three performances. Partnering both ladies was Thomas Hampson, in his captivatingly debonair portrayal of Count Danilo. Everyone was dazzled by the direction and choreography of Broadway's Susan Stroman, as well as the grand-scale sets by Julian Crouch and William Ivey Long's sumptuous costumes.

After an enormously invigorating creative process lasting more than three years, the eagerly-awaited world premiere of *Bel Canto* triumphed. Commissioned by Lyric and composed by Jimmy López to a libretto by Nilo Cruz (based on the bestselling novel by Ann Patchett), *Bel Canto* was curated by Lyric Creative Consultant Renée Fleming, whose dedication to the project was profoundly inspiring for all of us. Conducted by Sir Andrew and directed by Kevin Newbury, the production boasted a magnificent ensemble cast headed by Danielle de Niese in the central role of opera diva Roxane Coss.

Lyric's enviable record of success in Verdi repertoire was enhanced by the revival of *Nabucco*. This uniquely exhilarating work, the first triumph of the composer's career, had passionate advocates onstage in Željko Lučić, Tatiana Serjan, and Dmitry Belosselskiy, who gave stupendous performances in the central roles. Carlo Rizzi gave the work immensely authoritative style on the podium, and Matthew Ozawa (working with Michael Yeargan's sets and Jane Greenwood's costumes from Lyric's previous production) contributed a striking new staging.



Strauss's ever-fresh *Der Rosenkavalier* returned after a decade, introducing Lyric audiences to several important artists. Edward Gardner, one of his generation's most exciting conductors, gave a wonderfully buoyant spirit to this work, to which the orchestra responded with consistently superb playing. Directed by Martina Weber of Munich's Bavarian State Opera, the principals onstage truly lived their parts: Sophie Koch and Alice Coote sharing the title role, partnered by Amanda Majeski, Martin Gantner, and—in their Lyric debuts—Matthew Rose and Christina Landshamer.

Gounod's *Romeo and Juliet* brought our first production by Bartlett Sher, whose vast experience encompasses great successes in both opera and Shakespeare. His collaboration with conductor Emanuel Villaume and design team renowned both in opera and on Broadway (Michael Yeagan, Catherine Zuber, and Jennifer Tipton) gave this work a special fire and electricity. Joseph Calleja and Eric Cutler each played an ardent Romeo, opposite the enchanting Juliet of Ryan Opera Center alumna Susanna Phillips. Supporting them were sterling portrayals by Christian Van Horn, Joshua Hopkins, and—in a scintillating, crowd-pleasing American debut—Marianne Crebassa. The duel scene was masterfully handled by today's pre-eminent fight choreographer, the legendary B. H. Barry.

It was thrilling to welcome Plácido Domingo back to the Lyric stage, after an absence of more than a decade. The occasion was a memorable concert on January 9 for which he collaborated with another Lyric favorite (and a frequent Domingo recital partner), the dazzling Ana María Martínez, with Sir Andrew on the podium. The program of duets from opera and zarzuela was a glorious success, prompting Domingo to accept our invitation to return in 2016/17.

The excitement was similarly infectious on February 26, when Russian baritone Dmitri Hvorostovsky returned to the company where he made his American debut in 1993. The recital he presented, with Ivori Ilja at the piano, offered deeply moving artistry in songs of Glinka, Rimsky-Korsakov, Tchaikovsky, and Strauss.

Lyric's American Musical Theater Initiative continued with our fourth Rodgers and Hammerstein show, *The King and I*, in a production that originated at Paris's Théâtre du Châtelet. The exquisite exoticism of this work was memorably realized by the production's gifted team, headed by conductor David Chase and director Lee Blakeley. Kate Baldwin and Paolo Montalban exuded a dazzling chemistry in the demanding central roles.

Once again I must offer heartfelt thanks to Sir Andrew Davis, Renée Fleming; our Senior Management Team—Drew Landmesser, Roberta Lane, Mary Ladish Selander, Brent Fisher, Cayenne Harris, Elizabeth Landon, Nicholas Ivor Martin, Andreas Melinat, Lisa Middleton, Dan Novak, Will Raj, Rich Regan, and Michael Smallwood; our other full-time and seasonal staff; our remarkable president David Ormesher; our extraordinary volunteer boards; and our devoted Lyric audiences, who have so enthusiastically supported our activities throughout the season.



## CREATIVE CONSULTANT'S MESSAGE

*Supporting the creation of new work is essential to the future of any art form. It is what keeps an arts institution vibrant and relevant, instead of receding from the cultural dialogue as a mere preserver of historic works. Serving in the role of curator for the new world premiere of *Bel Canto* at Lyric Opera of Chicago has been one of the most rewarding experiences in my career.*

Award-winning author Ann Patchett and I have been friends since her best-selling novel *Bel Canto* was published in 2001. She agreed to allow Lyric to transform her tale of an opera singer in the midst of a hostage crisis into an opera. Sir Andrew Davis, Anthony Freud, and I began the search for a composer. After reviewing the work of more than 95 different composers, we selected the brilliant Jimmy López to create the music. Pulitzer Prize-winner Nilo Cruz wrote the libretto, and Kevin Newbury directed. To our delight, the world premiere received great critical acclaim and was a success at the box office. We look forward to its national television broadcast on PBS *Great Performances* in January 2017.

During the 2015/16 season, we began preparations for a major initiative which will continue through the 2017/18 season, *Chicago Voices*. Developed collaboratively with Lyric Unlimited, Lyric's education and community engagement division, this project aims to bring together thousands of Chicagoans in a celebration of the human voice. *Chicago Voices* includes a series of multifaceted collaborations, with community-created performances: expert panels and master classes; an all-star, multi-genre Gala Concert at the Civic Opera House; and *Chicago Voices Fest*—a series of events spanning several months and encompassing a wide range of educational and artistic opportunities for Chicagoans of all ages. Major support has been provided by The Andrew W. Mellon Foundation, the Ford Foundation, J. Thomas Hurvis and the Caerus Foundation, The Chicago Community Trust, the City of Chicago Department of Cultural Affairs and Special Events, and the Eisen Family Foundation.

Onstage, I was thrilled to portray Hanna Glawari in *The Merry Widow*, opposite the dashing Count Danilo of Thomas Hampson. Sir Andrew Davis led the Lyric Opera Orchestra and the audience was charmed by Lehar's gorgeous score and the beautiful Belle Époque production by Broadway great Susan Stroman.

My role as Advisor to the Ryan Opera Center continues to be an exceptionally fulfilling one. During each stay in Chicago, I work with ensemble members and staff, and my annual master class is an opportunity for donors and subscribers to see these amazing young artists hone their skills. The Ryan Opera Center continues its tradition of finding and developing the stars of tomorrow. The level of talent that this program draws from around the world has never been higher, and these are singers to watch.

I'd like to express my sincere thanks to the "Renée Brigade" for their generous continued support, and to all Lyric donors and subscribers who are supporting *Chicago Voices* and the Ryan Opera Center. It is because of you that these programs are possible, and that Lyric remains a cultural leader, not only for Chicago, but for the world.

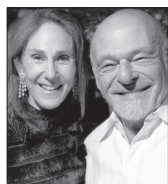

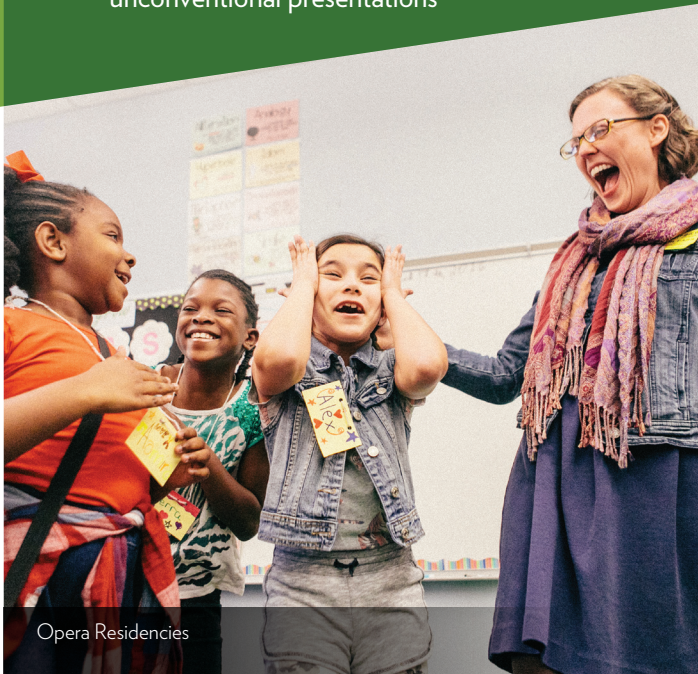

Through new initiatives and highly regarded ongoing programs, Lyric Unlimited endeavors to:

- Deepen and broaden Lyric's community service
- Develop collaborative relationships with a range of organizations throughout the Chicago area
- Explore the development of opera as an art form through innovative programming and unconventional presentations



Opera Residencies

### Some of the noteworthy programs and activities of Lyric Unlimited during the 2015/16 season included:

Building on Lyric Opera's distinguished history of education programs, Lyric Unlimited was established in 2012 to provide a relevant cultural service to communities throughout the Chicago area, including communities for whom opera and opera companies have been largely irrelevant. Lyric Unlimited's initiatives are integral to Lyric's mission to provide a service that is compelling, distinctive, and radical within the field while advancing the development of the art form.

With the growth of Lyric Unlimited, Lyric has seen an unprecedented level of interaction with audiences and community members. The 2015/16 season built on the programmatic achievements and dynamic relationships fostered in previous seasons to expand the initiative's reach and relevance within Chicago's broad and diverse communities. Longstanding educational programs such as *Opera in the Neighborhoods*, *Performances for Students*, and *Student Backstage Tours* continue to form the backbone of Lyric Unlimited, offering a range of touch points to engage students and teachers in the integration of the arts into classroom learning. This season,

Lyric Unlimited's *Opera Residencies* expanded to 40 classrooms in 15 different schools throughout the city of Chicago. Chicago Public School students, who participate free of cost, currently make up 92% of those engaged in this in-school program.

In addition, Lyric Unlimited has invested itself heavily in diversifying its range of new productions and activities, driven by Lyric's commitment to broadening our audience and to providing a service that is relevant, engaging, and accessible to audiences throughout the city we exist to serve.

During the 2015/16 season, Lyric Unlimited commissioned *Second Nature*, a new opera for youth, presented in partnership with the Lincoln Park Zoo. Following the premiere performances at the Zoo, *Second Nature* had more than 30 additional performances as part of the *Opera in the Neighborhoods* program.

In conjunction with the main stage world premiere opera *Bel Canto*, Lyric Unlimited developed a series of free, public events to engage both longtime opera patrons and audiences new to the genre by highlighting the opera's connections to the novel on which it was based, the social and political environment which surrounds the plot, and the composer's own journey to writing his first operatic work.

With Lyric's Creative Consultant Renée Fleming, Lyric Unlimited launched a major new initiative called *Chicago Voices*, which over the course of the next two years will bring together thousands of Chicagoans in a celebration of the human voice. *Chicago Voices* will highlight the unique heritage of Chicago vocalism, bringing together artists of all genres in participatory arts experiences and demonstrating how opera can have relevance to people of all backgrounds, ethnicities, and interests.

# BREAKING NEW GROUND

A CAMPAIGN FOR LYRIC | 

The *Breaking New Ground* campaign exceeded its 'silent phase' fundraising goal of \$100 million in October 2015 through a combination of cash contributions, pledges, and bequests, staunch evidence of the loyalty and generosity of Lyric's donor family.

Lyric is tremendously grateful for the significant support of our patrons. However, as our out-of-date stage equipment continues to deteriorate, it has become increasingly apparent that immediate action must be taken to maintain the highest standards of safety, quality, and financial stability. In the public phase of the *Breaking New Ground* campaign Lyric is raising additional funds specifically for stage renovations, which are absolutely vital for several productions in upcoming seasons. These funds will provide for the most pressing needs, including installing new stage lifts, a turntable, replacing and adding point hoists, installing a counterweight pipe automation system, and modernizing our stage lighting equipment. With these improvements, which are already underway, Lyric will continue to produce operas of the highest artistic quality while maintaining our commitment to fiscal responsibility.

When the Civic Opera House was built in 1929, it was the most state-of-the-art theater of its time. However, the stage has steadily deteriorated over the years, and Lyric grapples with the challenges of a performance space that is woefully ill-equipped and unable to

properly accommodate modern productions. These challenges influence every decision it makes about upcoming productions. It is very difficult to rent or co-produce with sister opera companies such as The Royal Opera House or San Francisco Opera because their technology is far more advanced.

Through the *Breaking New Ground* campaign, Lyric's goal is to raise funds to undertake the major purchases and renovations necessary to replace outdated, unsafe, and deteriorating equipment and to bring the facilities of the Civic Opera House up to 21st century artistic and technological standards. By the end of the 2016 calendar year, the *Breaking New Ground* campaign for stage equipment will raise \$1,700,000 for our most pressing equipment needs. Within the next two to three years, Lyric needs a total of \$7,600,000, with an ultimate goal of raising \$16,300,000 over the next five years.

A considerable investment in equipment will dramatically improve our ability to produce high-quality operas efficiently and cost-effectively and will reinforce Lyric's position as a leader in its field, creating and sharing innovative new productions of the absolute highest caliber with audiences, and sister opera companies around the world.

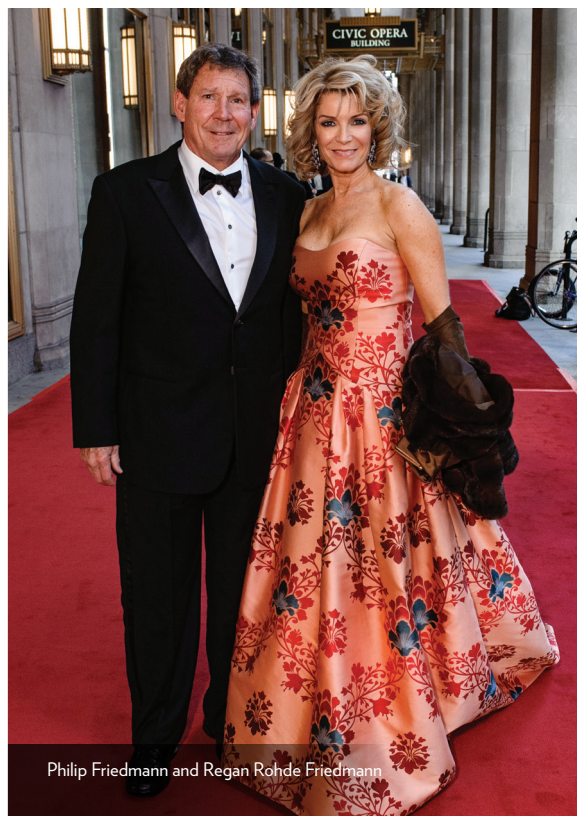

Ryan Opera Center pianist Mario Antonio Marra joined Lyric's music staff for *Cinderella* and played continuo for all performances. Several of our singers were featured with their senior colleagues and Craig Terry in the new *Beyond the Aria* recital series at the Harris Theater. Other collaborations included concerts with the Grant Park Music Festival, Rush Hour Concerts, and Art Institute of Chicago.

Audiences enjoyed the Ryan Opera Center's wonderful backstage workshop production of *The Marriage of Figaro* and Season Preview Concert, and several hundred Lyric donors and subscribers attended the Final Auditions in September. Radio listeners in Chicago were treated to the fourth season of our monthly Recital Series on 98.7 WFMT, the only such program of its kind in the country.

Complementing the numerous performance activities were the program's extensive training opportunities which covered the broad spectrum of skills required for operatic artistry. These included work with our incredible resident faculty, guest master artists, and several mainstage artists, as well as Creative Consultant Renée Fleming, Music Director Sir Andrew Davis, and General Director Anthony Freud. Ensemble members auditioned for more than a dozen agents and opera companies throughout the season and received invaluable feedback from Anthony Freud and Lyric's artistic staff. They also received expert career advice on topics ranging from maintaining vocal health to financial planning.

The season's accomplishments were celebrated at *Rising Stars in Concert*, the annual showcase performance which featured all of our artists and included Mario Antonio Marra's debut on the podium. Michael Christie returned for the second consecutive year to lead the concert.

## TREASURER'S REPORT

Fiscal 2016 marks Lyric Opera's 61st season of artistically thrilling opera. During the year, we also successfully performed the fourth musical in our American Musical Theater Initiative and continued our acclaimed Lyric Unlimited programming, achieving our goals of community engagement and artistic innovation.

We ended our 2016 fiscal year with breakeven results. Operating revenue and support was \$78.2 million, with 264,256 tickets sold generating \$26.8 million in ticket revenue. Annual support from our donors and operating funds provided by our *Breaking New Ground* fund contributed \$38.8 million to our operating costs.

We thank our generous Lyric donors and sponsors, whose support allowed us to produce an outstanding artistic season, exciting new productions, and moving new commissions.
